Blurring the Boundaries: How the Additional Grounds for Post-Grant Review in the America Invents Act Raise Issues with Separation of Powers and the Administrative Procedure Act

Does the America Invents Act ("AIA") grant the U.S. Patent and Trademark Office ("PTO") the ability to invalidate patents based on a legal question? In his forthcoming law review article, University of Dayton School of Law graduate Benjamin J. Christoff argues that these laws do not permit the PTO to exercise such a broad judicial power as invalidating patents based on a legal question.

The AIA, 35 U.S.C. § 324(b), permits the PTO to exercise jurisdiction over granted patents if the petitioner presents a "novel or unsettled legal question." Mr. Christoff analyzes the decisions of

the Supreme Court, the PTO, and their interactions with the Administrative Procedure Act ("APA") to support his conclusion that the current state of the law does not permit the PTO to overstep its bounds by invalidating patents based on a legal question. Instead, Mr. Christoff argues the PTO, as an executive agency, should play the more limited and traditional role of scrutinizing patent applications and reserve jurisdiction over granted patents on the basis of a novel legal question to federal courts. This allegedly would better preserve the rule of law, avoid the politicization of the patent system, and better accord with historical ideas about the PTO's role.

The University of Dayton School of Law faculty recently awarded Mr. Christoff the Francis J. Conte award for Excellence and Dedication for the article. It is set to be published in the upcoming University of Dayton Law Review, Journal 39, Issue 1.

Call for Papers: Law + Infomatics Symposium
